Brief Rules and Regulations for Participation in Exhibition

1. Stall Booking:

Stalls are available for display/retail sale of Artefacts and Wares from all the 22 Districts of Punjab at Exhibition to be held at Sultanpur Lodhi from 01-11-2019 to 14-11-2019 on the occasion of 550th Prakash Utsav of Sri Guru Nanak Dev Ji. Stalls will be allotted to handicraft artisans, Self Help Groups, Cooperatives within the State of Punjab only. Allotment of stalls will be free of cost for artisans, SHGs and cooperatives,

2. Allotment of space to the participants:

Allotment of Stalls will be free of cost for artisans, Self Help Groups and Cooperatives. However, In case applications received are more than the available stalls, stalls will be allotted on the basis of first come first serve basis or through draw of lots, taking into consideration suitability of the products subject to the fulfillment of terms and conditions failing which application will not be considered.

Submission of application does not automatically confer a right for allotment of space. Rights of Allotment of stalls will rest with Managing Director, PSIEC.

3. Expenses:

All expenses of the exhibition like preparation of catalogue, freight and cartage of exhibits are to be borne by the participant.

4. General:

- i) Only Products from Punjab State will be allowed to be displayed / sold.
- ii) In the event of postponement/abandonment / cancellation of the Fair / Exhibition, or in case of exhibits not being displayed due to any reason beyond the control of the PSIEC, it shall not be liable for any loss or liability.
- iii) The stall allotted to the participant is to be exclusively used by them for display/sale of their products. **Sub-letting is not permissible.** Violation of

this clause may lead to cancellation of stall allotted/forfeiting of amount deposited and they will be debarred from future participation.

- iv) Participant will be responsible for the payment of applicable taxes. They have to produce certificate in this regard before vacating the stalls failing which material will not be allowed to be removed after the close of the fair.
- v) Any dispute or differences arising out of these terms and conditions of participation shall be referred to the Managing Director, PSIEC whose decision of award shall be final and binding.
- vi) Any terms & conditions can be changed/alterd at the discretion of Management at any time without assigning any reason thereon.
