**CIRCULAR**

It is informed that EPFO has intimated that they have entered in the era of technology to make their organization paperless and in order to encourage transparency and to reduce the risk of fraudulent/wrong payment, the office of EPFO has decided that no pension claim form 10-D in physical should be accepted from the members without any valid reason. However, physical Form 10-D in Pension case are allowed to be accepted only in case of following cases:-

1. Wherein UAN has not been allotted to the members and date of exit is prior to 01.07.2014 and now account is inoperative.
2. Where in, the establishment are marked closed/non-operational.
3. Where in the establishments are in liquidation.

In view of the above, all the Officers/Officials are hereby requested to fill pension claim form (10-D) online with help of EPF Section, Head Office or Nominated Officials at Field Office (details enclosed herewith) by ensuring that all the necessary document have been uploaded before forwarding the claims to office of EPFO , Chandigarh.
