PUBLIC NOTICE

Cancellation of allotment of Plot No. F-461, Phase VIII-B, IFP Mohali and resumption of the plot by PSIEC

It is brought to the notice of General Public and all concerned that PSIEC has made allotment of Plot No. F-461, Phase VIII-B IFP Mohali measuring 500 sq yds. on certain terms and condition contained in the allotment letter dated 13.07.2004 in favour of M/s Aroma Enterprises. The allottee of the plot failed to remit the outstanding dues of the plot in question and hence, breached the terms and conditions of allotment letter. The allottee was issued registered show cause notice vide letter dated 12.12.2022 on the given and last known address, as to why the allotment may not be cancelled, due to non-remittance of outstanding amount of the plot in question. The said show cause notice received back undelivered from the postal authorities with the remarks "No such person". Whereas PSIEC has made another attempt to deliver this show cause notice through its field staff vide letter dated 03.01.2023 but the field staff could not also deliver the show cause notice and returned the same vide letter dated 05.01.2023 with remarks "ਪਲਾਟ ਨੰਬਰ F-461 ਫੇਜ਼ 8-B, ਮੋਹਾਲੀ ਦੇ ਅਲਾਟੀ ਦੇ SCN ਉਤੇ ਦਰਸਾਏ ਗਏ ਪਤੇ M/s Aroma Enterprises (Sh. Maninder Singh), R/o H.No. 2068, Sector 71, Mohali) ਉਤੇ ਜੇ.ਈ. ਇੰਚਾਰਜ ਵੱਲੋਂ ਨਿੱਜੀ ਤੌਰ ਤੇ ਪਹੁੰਚਿਆ ਗਿਆ ਪਰੰਤੂ ਉਕਤ ਮਕਾਨ ਮਾਲਕਾਂ ਵੱਲੋਂ ਦੱਸਿਆ ਗਿਆ ਹੈ ਕਿ SCN ਉਤੇ ਦਰਸਾਏ ਗਏ ਨਾਮ ਦਾ ਕੋਈ ਵੀ ਵਿਅਕਤੀ ਇਸ ਜਗ੍ਹਾ ਤੇ ਨਹੀਂ ਰਹਿ ਰਿਹਾ ਅਤੇ ਨਾ ਹੀ ਇਸ ਤੋਂ ਪਹਿਲਾਂ ਰਹਿੰਦਾ ਸੀ ਜਿਸ ਕਰਕੇ ਉਹਨਾਂ ਵੱਲੋਂ SCN ਲੈਣ ਤੋਂ ਮਨ੍ਹਾ ਕਰ ਦਿੱਤਾ ਗਿਆ ਇਸ ਦੇ ਨਾਲ ਹੀ ਉਕਤ ਮਕਾਨ ਮਾਲਕਾਂ ਤੋਂ ਨਾਮ ਪੁੱਛਿਆ ਗਿਆ ਪਰੰਤੂ ਉਹਨਾਂ ਵੱਲੋਂ ਕੁਝ ਵੀ ਦੱਸਣ ਤੋਂ ਸਾਫ ਮਨ੍ਹਾ ਕਰ ਦਿੱਤਾ ਗਿਆ। Now, I Kumar Amit, IAS, Managing Director in exercise of the powers vested in me hereby cancel the allotment of Plot No. F-461, Phase VIII-B, IFP Mohali and resume the same on account of violation of terms & conditions of allotment letter by the allottee by not remitting the outstanding dues.

Through this Public Notice, general public and all concerned are hereby informed that allotment of Plot No. F-461, Phase VIII-B, IFP Mohali has been cancelled and stand resumed by PSIEC.
