With a view to rehabilitate the Existing units/ entrepreneurs/workshop holders/ ancillary shops and services affected due to construction of road for National Highway and beautification plan of Maluut City District Muktsar, the Governor of Punjab is pleased to notify a scheme for allotment of industrial plots available in the Focal Point, Malout, District Muktsar as under:-

- i. Existing units/entrepreneurs/workshop holders/ ancillay shops and services affected due to the construction of road for National Highway and beautification plan of Malout City duly identified and verified by a committee under the chairmanship of Deputy Commissioner. Muktsar, and comprising of General Manager, District Industries Centre, Muktsar Sub Divisional Magistrate, Malout, and District Town Planner, Muktsar shall be eligible to apply for the allotment of industrial plots in the Focal Poini Malout, District Muktsar. The Committee will assess the eligibility of such applicants on the basis of permanent SSI registration with General Manager, District Industries Centre, Mukatsar and/or, electricity bills etc.
- ii. The committee headed by Deputy Commissioner, Mukatsar as per (i) above shall scrutinize and verify the applications for allotment of plots under this scheme.
- iii. The application for allotment of industrial plots in Focal Point Malout in this scheme shall be invited by the office of General Manager, District Industries Centre, Mukatsar by giving local publicity from the identified persons/enterprises in accordance with the scheme. The applications shall be received in the office of General Manager, District Industries Centre Mukatsar.

Applicants found eligible by the District Level Committee as at Sr. No. (i) above shall be eligible to apply only.

- iv. The committee headed by Deputy Commissioner Mukatsar as per
  (i) above shall scrutinize & verify the applications as per
  eligibility provisions of the scheme and finalize the decision of
  allotment. The list of recommended/successful applicants shall be
  sent by Deputy Commissioner Mukatsar to PSIEC for issuance of
  allotment letters as per provisions of the scheme.
- v. If the number of eligible applicants exceeds the number available plots in respective category/size. Allotment of plats shall be he through draw of lots.
- vi. 15% of the plots coving the size 500 sq yards and 1000 sq yards out of overall availability shall be **earmarked** for allotment under Off the Shelf Scheme in accordance with the provisions of land allotment policy of State Government dated 9.4.2008.
- vii. The concerned Existing Units/ entrepreneurs/ workshops holders/ancillary shops shall shift their activities /business on the allotted plot and start production/commence business within a period of one year from the date of allotment failing which the allotment would be deemed to have been cancelled.
- viii. The land/plot allotted under this policy will not be transferable.
- ix. The other terms and conditions of allotment will remain the same as contained in the land allotment policy notified by the State Government on 9.04.2008
